Federal Sheep And Goat ID Requirements For Scrapie

Sheep and goats that are sexually intact and used for breeding, show and/or exhibition are required to have official individual animal and premises identification prior to sale or movement. For further information, contact Mike Greenly, USDA, Albuquerque Office, (505) 761-3160.

Livestock Inspection

•Proof of ownership (NMLB "Form 1" inspection certificate) must accompany the animal when traveling; this will assure that all requirements are met.

The following requirements must be met:

1.A NMLB APPROVED fair ear tag provided by the NMLB and a Form 1 inspection issued by the NMLB.

•All sexually intact sheep and goats must have an official USDA scrapie tag and/or breed registration tattoo, regardless of breed, no exceptions.

•All sexually intact goats must have a scrapie tag prior to TB testing. The USDA scrapie tag is the official identification required for TB testing goats.

•Sexually intact goats ≥ 6 months must have a negative TB test within 90 days of the exhibition.

•Due to the nature of tuberculosis and the low risk of susceptibility in sheep; sheep do not require a TB test.

•Accredited TB free herd status will be recognized.

Sheep

Sheep commentary is due at time of entry. **Late commentary will not be accepted.** Girls showing a sheep must have two (2) commentaries - 1 about sheep ONLY and 1 about garment. Entrants in this class must be residents of New Mexico between the ages of 2 and 19. They must show at halter a sheep with no more than two teeth. Purebred ewes of any wool breed are eligible. Ewes will be checked in Friday, September 10th, 2010 between 7:00 AM and 5:00 PM. The ewe must NOT have more than 2 permanent teeth. If the ewe has more than 2 teeth, an automatic deduction of 50 points will occur on the ewe.

Judging

The entrants will be judged as follows:

The Sheep:

General Appearance - 45 points. Good breed character, size and scale, body conformation, soundness of feet, legs and mouth, and wool quality representative of breed.

Fitting The Sheep - 30 points. The ewe should be attractively fitted and groomed, but not colored or artificially prepared. The ewe should be clean, smoothly blocked in long wool (wool should be at least 1 inch long) in good condition, alert, stylish and well balanced.

Leading Ability - 30 points. The ewe should respond calmly to the halter and stand quietly when handled by the judge.

Best Wool Breed Ewe - 1-10 points possible. Judged on the highest quality ewe.

The Contestant:

General Appearance - 30 points. Grooming (hairstyle and make-up) should enhance rather than distract from chosen outfit. The contestant should handle self and animal with poise in the show ring.

Fashion Consciousness - 30 points. The outfit should be in step with current fashions and complement the contestant.

Sewing Technique And Fit - 30 points. Major articles of clothing must be made of at least 60% wool and be homemade or handmade. Ready made woolen garments are not permissible. Non-wool accessories are permissible. Accessories such as hat and gloves should complement the garment.

Personality - A coke party will be held for contestants at 2:00 PM on Saturday, September 12, 2009. The Sr. contestants will be asked questions by two judges. If the Sr. exhibitor does not attend they will receive a zero on the Personality score.

The Overall Picture:

Poise And Behavior - 60 points. Overall general appearance of contestant and sheep in show ring.

Additional Prizes:

A Belt Buckle will be awarded to the Winner from each class from Expo NM. \$50 will be awarded by Braham Hindi & Sons, Duran NM for the winner of the Best Wool Bred Ewe. In case of a tie, the tie will be broken on the ewe.

Wool Pelt will be awarded by the New Mexico Wool Growers for the winner of the Best Wool Breed Ewe. In case of a tie, the tie will be broken on the ewe.
